Retief, in the name of the Emigrant Farmers, now sent word to Umsiligaas, the Matabele King, that, on condition of his restoring everything which had been taken by his Impis, peace would be granted to him; but that, if he did not comply with this demand, hostilities would be resumed against him. No reply was received to this communication. The Commandant-General had in the meantime visited the friendly Chiefs, Moroko, Tawane, Sikonyella, and Moshesh, and concluded alliances with them.
